Royal Kennel Club Working Trials Regulations I paragraph 24 – Minimum judging experience required for PD/TD Stakes at Championship Working Trials.

On a person's first appointment to judge Championship Working Trial Certificate Stakes, the minimum conditions which apply are:-

- 1) • Must have a minimum of 5 years' experience of judging at Royal Kennel Club licensed Working Trials.
 - Must have judged a WD Stake at two or more Championship Trials.
 - Must have judged two or more Open TD Working Trials for TD Judges and PD Judges.
 - Must have qualified a dog "Excellent" in the nominated Stake.
 - Must have been assessed by a Royal Kennel Club approved assessor.
 - Must have attended a Royal Kennel Club Working Trial Regulations and Judging Procedure seminar and passed the Regulations and Judging Procedure examination
 - Must have attended a Royal Kennel Club practical Working Trials seminar. In addition PD Judges must have attended a Royal Kennel Club PD regulations and judging procedure seminar and passed the relevant examination.
- 2) The person must have been assessed. Proposed TD judges must be assessed at either a TD Open Stake or a WD Championship Stake. Proposed PD judges must be assessed at a PD Open Stake.

NOTE: A person approved to judge a Championship Working Trial Certificate Stake may not judge the same stake within a period of six calendar months, the relevant date being the last day of each trial.
