





A guide to help you complete the application for the registration of puppies produced by artificial insemination (AI)

The owner who wishes to register a litter of puppies by AI should complete this form.

Whilst a special application is required at the time of registration, prior approval is not required to register a litter produced by Al but the breeder must complete this form and send it together with the litter registration form.

All litters produced by AI will be subject to existing Royal Kennel Club registration regulations.

The Royal Kennel Club will accept an application to register a litter produced by AI from either overseas dogs or those domiciled in the United Kingdom, but the AI must be declared on the litter application form.

If these conditions are met, then the owner need only ensure that the AI form is completed and submitted along with the litter application form (form 1) at the time of registration.

In the case of a stud dog domiciled outside of the UK, the dog must be registered with a recognised overseas kennel club. with which the Royal Kennel Club has a reciprocal agreement or which has full membership, associate membership or contract partnership of the FCI, and confirmed by an official three generation pedigree issued by the Royal Kennel Club. The registration certificates of any resultant progeny will be endorsed with the initials (AI) after the dog's name to indicate that they were bred by artificial insemination.

Please note:

From the beginning of 2019, the use of surgical insemination has been banned by the Royal College of Veterinary Surgeons. Therefore, no applications will be accepted whereby the litter was produced using this method.

As from July 2023, the RCVS confirmed that any artificial insemination must be carried out by a veterinary professional; this position is for both transcervical and intravaginal inseminations and reflects the legal position.

Applications will not be accepted unless this AI form contains both a signature from a veterinary professional and a veterinary practice stamp confirming that the insemination has been carried out at a veterinary establishment.

N.B. It is essential that the applicant conforms to all current requirements imposed by the Department of Environment, Food and Rural Affairs (DEFRA) on imported semen.
