

# Registration of a single dog on the Breed Register







### Application for the registration of a single dog on the Breed Register - Form 9

Only to be used for the registration of those breeds who are registered with the clubs or organisations listed below.

#### 1 Applicant and additional owners

All registered owners of the dog should include their name on this application and all owners will be recorded and printed on any publications and documents relating to the dog. The applicant is the person who is applying for the registration either as the sole owner or in partnership with additional owners. The address stipulated on this application should be the address where the dog resides and as printed on the registration certificate issued by the relevant UK club. As such, any documentation will be sent directly to this address.

In the case of joint ownership, you, as the applicant of this application will act as the point of contact in regard to matters pertaining to the Royal Kennel Club.

However, any additional owners will also be able to view the dog's information if they sign up for an online account. Please note, in the case of joint ownership, any other joint owners of the dog must include their title, first name/initials, surname and unique email address in the additional owner section. The declaration must be signed by all registered owners of the dog.

#### 2 Dog details

For ISDS registration you will be required to send one of the following a), the dog's ISDS registration certificate and pedigree or b), the sire's and dam's ISDS registration certificates and pedigrees or c), if both parents are ISDS registered but are also registered on the Royal Kennel Club breed register, both parent's ISDS registration certificates. (If using route C, please provide the sire and dam's ISDS registration details in section 2 of the application form.

For all other clubs/organisations we will require a photocopy of the official pedigree and owner registration certificate certified by the club or organisation.

For dogs which are registered either with the JRT Club of Great Britain or the British JRT Club the owner will need to send two colour photos of the dog (one head study and one profile view of the whole dog), and a three generation pedigree issued by the club. Representatives from the Royal Kennel Club will examine the details provided and, if acceptable, the registration will proceed.

#### Dog naming guidelines (please read carefully)

- The dog's name that appears on the clubs registration certificate must be incorporated as part of the name.
- ii. A name must consist of more than one word but not exceed 24 letters.
- iii. A name which conflicts with an active kennel name granted to another person will not be accepted, unless it is the name that the dog is registered as with the official club/organisation.

- iv. The surname of the breeder/current owner is not acceptable.
- v. If a kennel name is to be used, it must appear as the first word if named by the breeder. If you are not the breeder of the dog, or the breeder of both the parents, the kennel name must appear as the last word of the name.
- vi. Initials cannot be used & abbreviations may be disallowed.
- vii. Canine terms are not permissible, e.g. "dog", "bitch", "kennel", "Champion" and specific names of breeds.
- viii. A registered name cannot be used again within a breed. The Royal Kennel Club reserves the right to refuse any name that it considers inappropriate or offensive. The Royal Kennel Club also retains the right to request a fresh name for any dog after the registration has been accepted, in the event of a complaint being lodged with the Royal Kennel Club that is upheld.

#### 3 Breeder(s) name & address

The breeder is the person who bred the dog. If the application is for a dog registered with the ISDS, the breeder's signature is not required. However, if the application is for a dog born to a bitch registered with the ISDS, or if both parents are dual registered with the ISDS & the Royal Kennel Club Breed Register, the breeder's details and signature are required and must match the current ownership of the bitch on the ISDS certificate which copy must be sent in with the application.

#### 4 Fee

The application fee to register a single dog is £21.00.

#### 5 How to pay

Once you have completed this form, please send it together with the appropriate fee to the address at the bottom of the page.
